Social media has been always described as the channel through which knowledge is transmitted between lecturers and students. This social media has been utilized by colleges in a way to encourage collaborative learning and social interaction. Hence, this study explores the most used social media that students used to send and received notification, files, and documents from their lecturers or colleagues, based on the results analysis presented that 48% of the students used Facebook as a leaning tool because it helps them to send and received notification, documents and files from their lecturers. Moreover, this research also investigates the most use social media site that students used to create groups for assignments or classes, the results was found that 50% of the students used WhatsApp in order to create groups for assignments, classes and other school activities. Likewise, this research determines the relationship between dependent and independents variables, based on the results analysis shows that there is a significant relationship between the variables. Moreover, 360 respondents participated in this study. The Statistical Package for the Social Sciences (SPSS) was used to analyse the data obtained. Therefore, the research found that there is a significant impact between dependent and independents variables on collaborative learning through the use of social media which might lead to a better students' academic learning performance.
